



**GRAND TARGHEE RESORT  
RELEASE OF LIABILITY AND INDEMNITY AGREEMENT**

In consideration for my participation in Summer Chair Lift Rides  
at Grand Targhee Resort, I understand, acknowledge and agree as follows:

- 1. I understand that use of the summer chair lift and participation in any activities at Grand Targhee Resort ("GTR") can be dangerous. I further understand that there are inherent and other risks and dangers associated with these activities, which may be known and unknown, and which include, but are not limited to, variations in terrain; existing and changing surface conditions; slick or uneven surfaces; water bars; ruts; stumps; changing weather conditions; lightning; difficulty with route finding; high altitude; wildlife; insects; lift, mechanical and equipment failures; lift closures; sudden stops; slips; falls; cliffs; streams; dehydration; equipment malfunction; sun exposure; collisions with others; and collisions with natural and man-made objects and features which may or may not be marked. I further understand and agree that GTR does not operate as a ski resort during the summer months and that, should I choose to carry any ski or snowboard equipment with me as I ride the chairlift as a foot passenger, I acknowledge there are no on-mountain services available during the summer season, including, but not limited to, ski patrol, directional signage, markings of hazards, or closed areas, and that I am participating in a backcountry experience. I acknowledge that trail and other mountain improvement activities and equipment, and other vehicles may be encountered at any time. There may be contact with plants, animals or insects that could create hazards such as stings, allergies, and other serious injuries and associated diseases. I understand the chair lift could stop at any time and that if it does, myself and other passengers will be required to evacuate the chair lift and the mountain. I acknowledge I may be required to negotiate hazardous terrain in and/or around Grand Targhee. In the event of an evacuation, I understand that medical care and treatment may be delayed. I recognize that falls occur and injuries are a common and ordinary occurrence of the above activities. I understand that accidents, injury, illness, incapacity or death can arise in conjunction with participating in the above activities. In consideration for participating in any activity at GTR, I hereby freely and expressly agree to accept and assume any and all risks in connection with these activities.
- 2. I further agree to forever release, discharge, waive, save and hold harmless, indemnify, and defend Grand Targhee Resort, LLC, GLT Holdings, LLC, their owners, subsidiaries and/or affiliates, officers, directors, shareholders, employees, agents, the U.S. Forest Service and all other applicable landowners, sponsors and insurance carriers (hereinafter "Releasees") from and against any and all claims, demands, causes of action, liabilities, actions, and any and all medical expenses or other related expenses, including damage to property, asserted by others, by me, or on my behalf, my estate, executors, heirs, or assigns brought under any theory of legal liability, INCLUDING ORDINARY NEGLIGENCE, arising directly or indirectly out of my use of the facilities, resort area or resort lifts at GTR, or my presence on GTR premises. The above release includes, but is not limited to, any and all damages occasioned in the event of an incident, illness, or other incapacity, death, or damage to property, however caused. If I want financial protection against personal injuries, I understand that I must obtain my own life, liability and health insurance to protect my family members and myself. I understand and agree that this release is applicable to each and every day that I participate in any activities at GTR. I understand and agree that this release is applicable to each and every day that I participate in any activities at GTR.
- 3. I warrant that I am in good physical condition and know of no medical or health reasons why I should not participate in any of the above activities. I authorize GTR to transport me or arrange for my transportation to a medical clinic or other medical facility should I become incapacitated and unable to make an informed decision. I agree that upon such transport, Releasees shall have no responsibility for me and I agree to indemnify and hold harmless Releasees from any costs incurred and claims therefrom.
- 4. I understand that this agreement shall be binding upon my heirs, executors, administrators, and assigns and shall be governed by Wyoming law. This agreement shall be binding to the fullest extent permitted by law. I also understand that if any part of this agreement is determined to be unenforceable, all other parts shall be given full force and effect. I agree that any claims that I may bring against the Releasees shall be submitted to the jurisdiction of the state court in Wyoming, Teton County, and that no claims against the Releasees shall be brought in any other jurisdiction or venue.
- 5. I further state that I am of lawful age and legally competent and agree to abide by the terms and conditions set forth herein. I understand that the terms of this document are contractual and not a mere recital. I am aware that I am releasing certain legal rights that I otherwise may have and I have signed this document as my own free act.

I agree to indemnify the Releasees for any and all claims whatsoever brought by the Child; and I agree to indemnify the Releasees for any and all claims brought by a third party arising in connection with the Child.
